Previously Provisional Recognition has been accorded to the classes I TO X (EM) of Sasi E.M. High School, Kadakatla, Tadepalligudem, West Godavari for the year 2007-08 to 2016-17 in Proceedings Rc.No. 5415/A1/2007, Dated.22.01.2008 of the Regional Joint Director of School Education, Kakinada in the reference 5th cited. The Correspondent has submitted the application for Renewal of Recognition for the classes VI TO X (EM) in the school for the years from 2017-18 to 2026-27. The District Educational Officer, Eluru, West Godavari District has verified the application for Renewal of Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994. Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby accords Renewal of Recognition for a period of 10 (Ten) years i.e., for the academic years from 2017-18 to 2026-27 for the classes VI TO X (EM) subject to fulfillment of the following conditions in Sasi E.M. High School, Kadakatla, Tadepalligudem, West Godavari without Grant-In-Aid now or in future.

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized officer from the time to time.
2. That the Educational Institutions shall serve the needs of the locality more particularly.
3. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposal for Renewal of Recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.

14. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
15. The management informed that no thatched roof accommodation is allowed to run the School.
16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
18. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
19. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
20. The school shall have first aid kit and the teachers shall be trained in first aid.
21. The Correspondent of the concerned school is hereby informed to file an affidavit by April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
22. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
23. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
24. That the management has to maintain trained teachers at all time.
25. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
26. That the Management of the school is informed to obtain the Occupancy Clearance from the Fire Services Department concerned for the complete period of recognition now accorded without fail as the present Occupancy Clearance in the Fire NOC.
27. That the Recognition now granted is subject to genuineness of the Fire No Objection Certificate issued by the Fire Service Department concerned.
28. That the Management of the school is informed to obtain the Structural Soundness Certificate for the Executive Engineer, R&B / Panchayat Raj immediately and submit the same to this office time to time for the entire period of Recognition.

If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed.

The Mandal Educational Officer, Tadepalligudem in reference 4th cited, has applied for according Renewal of Recognition to **Sasi E.M. Primary School, Kadakatla, Tadepalligudem, West Godavari District for classes I to V (EM) for the year 2017-2018 to 2026-2027**. The Inspecting Officer and Mandal Educational Officer, Tadepalligudem has verified the application for Renewal of Recognition with reference to the conditions laid down in the references cited and caused inspection and submitted his report in reference 4th cited.

After careful examination of the proposals from the society, the inspection report of the Inspecting Officer and also rules in force in the references cited, Renewal of Recognition permission is hereby accorded to **Sasi E.M. Primary School, Kadakatla, Tadepalligudem, West Godavari District for classes I to V (EM) for the year 2017-2018 to 2026-2027**, without aid, subject to the following conditions:

1. that the permission/Recognition accorded is valid for mentioned school building, address, Classes, medium and the period only. If the school building and/or address changed and/or other classes and/or medium opened without proper permission from the competent authority, the permission/recognition will be cancelled without prior notice.
2. that the society shall abide by the instructions, rules and regulations made by the Government and/or District authority from time to time.
3. that the Educational Institution shall serve the needs of the locality more particularly and shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. that the school timings, vacations and mid-term holidays shall be maintained as prescribed by the Government and/or District authority from time to time.
5. that the qualified staff, within the age limits and qualifications prescribed by the Government for Government Employees shall be followed and, shall be appointed as per the staff pattern and should be provided sufficient facilities and the results of the institution shall be satisfactorily every year.
6. that the Records, Audit Report, Administrative Report and list of Governing body of the Educational Society shall be furnished to the District Educational Officer, West Godavari, every year by 30th September at the latest.
7. that the pay / fee structure fixed by the Governing body shall be got approved by the District Educational Officer, West Godavari, every year.
8. that all the conditions prescribed in the RTE Act, 2009, and Government orders from time to time which are not specified in these orders shall also be complied with.
9. that the school shall not be closed without giving notice both to the parents and District Educational Officer/ competent authority at least 6 months before and the permission will be given to close the school only from the date on which summer vacation is declared.

10. that the society shall submit the proposals for renewal of temporary recognition in proper manner in advance i.e., at least 6 months prior to the date of expiry of the present recognition.
11. that the Management should not ask any grant from the Government or Department now or in future and that corporal punishments should not be awarded to the children and abide to the Child Rights without fail.
12. In any deviation on the specified conditions herein and also the Government orders from time to time, action will be taken to cancel the Recognition.
13. That the management shall obtain renewal of fire certificate for every year from the District Fire Officer and submit the same to this office without fail.
