Previously opening permission has been accorded to the classes VI to X under EM to Sasi English Medium School, Sangivalasa , Bheemunipatnam , Visakhapatnam District from the years from 2018-19 vide reference 4th cited. Now the Secretary & Correspondent, Sasi English Medium School, Sangivalasa , Bheemunipatnam , Visakhapatnam District has submitted the application for granting of provisional recognition for class VI to X under EM for the years from 2018-19 to 2027-28 vide reference 5th cited. In the reference 7th cited, the District Educational Officer, Visakhapatnam has verified the application and submitted for granting of Provisional Recognition with reference to the Inspection Report of the Inspecting Officer (vide reference 6th cited) and as per the G.O.Ms.No.1 Education, Dated.01.01.1994 and its amendments.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Visakhapatnam who is the competent authority is hereby granted provisional recognition to Sasi English Medium School, Sangivalasa , Bheemunipatnam , Visakhapatnam District for a period of 10 (Ten Years) i.e., for the academic years from 2018-19 to 2027-28 for the class VI to X under EM based on the report of the District Educational Officer, Visakhapatnam subject to fulfillment of the following conditions.

- 01 That the society shall abide by the rules and regulations made by the Government or authorized officer from time to time.
- 02 That the Educational Institutions shall serve the needs of the locality more particularly.
- 03 The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- 04 That the school timings, vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
- 05 That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed by the management with own funds as per the staff pattern.
- 06 That the results of institution shall be satisfactory every year.
- 07 That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
- 08 That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 09 That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 10 That all the conditions prescribed in the said G.O.'s and other orders which are not specified in this order shall be complied with
- 11 That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before
- 12 That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13 That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
- 14 That the society shall provide fire safety measures in the school as per the No Objection Certificate.
- 15 The management is informed that no thatched roof accommodation is allowed to run the School.
- 16 The management shall provide proper adequate Toilets / sanitation facility to the students & Staff.
- 17 Proper and adequate safety measures shall be taken for the students within the school campus and also near the school premises.
- 18 The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 19 The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the students.
- 20 The school shall have first aid kit and the teachers shall be trained in first aid.
- 21 That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
- 22 The management of the school is hereby informed to renew sanitary certificate from the competent authority ever year and same should be submitted to the District Educational Officer, Visakhapatnam through the inspecting officer.
- 23 That the management shall ensure the Accounts of this school are audited by an authorized Chartered Accountant every year.
- 24 That the management has to maintain trained and qualified of APTET Teachers at all time.
- 25 The Management is hereby informed to file an affidavit before April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
26. The management of the school is hereby informed to renew the FIRE NOC from the competent authority ever year and same should be submitted to the District Educational Officer, Visakhapatnam through the inspecting officer.

If the management fails to comply with the above conditions promptly the Recognition now granted will be reviewed.

Receipt of these proceedings should be acknowledged.

In pursuance of the reference 1st & 2nd cited, permission was accorded to start a school for classes I to X in English Medium to the Sasi Educational Society, Velivenu as **Sasi EM School, Sangivalasa, Bheemunipatnam Mandal Visakhapatnam District** for the academic year 2018-19.

The Regional Joint Director of School Education, Kakinada has accorded opening permission to **Sasi EM School, Sangivalasa, Bheemunipatnam Mandal Visakhapatnam District** with Classes VI to X (English Medium) during the academic year 2018-2019 Under the management of Sasi Educational Society, Velivenu, W G Dist.

After careful Examination of the proposals and as per the orders in referene 3rd cited, the District Educational Officer, Visakhapatnam is here by accorded permission for opening of **Sasi EM Primary School, Sangivalasa, Bheemunipatnam Mandal Visakhapatnam District** with the following classes subject to the following conditions.

1. That the society shall abide to the rules and regulations in the Govt. Order cited above.
2. That the society shall provide the necessary amenities like accommodation, Sanitary facilities, drinking water facilities, furniture, library, laboratory equipment, play field required staff as per the staff pattern and other facilities are necessary before approaching the competent authority for recognition.
3. That the society shall apply for recognition on or before 30.04.2019 at the latest duly fulfilling all the conditions stipulated in G.O.Ms.No 1 Edn dt 01-01-1994 and in subsequent amendments issued to the said G.O by the Govt. from time to time.
4. That the permission accorded is restricted to the academic year 2018-19 only and it not valid for the subsequent academic year.
5. That the permission is accorded to Sasi Educational Society, Velivenu to start a school in Sangivalasa Village, Bheemunipatnam, Visakhapatnam District and no other society or body open a School on their behalf of.
6. That the permission does not confer any right on the society for claiming for recognition.
7. That the permission is accorded to open the School in Sangivalasa Village of Bheemunipatnam locality and there shall not be any change the premises or locality.
8. That the society shall provide the necessary material even it costs more that the deposit amount.
9. The Proposals of recognition will not be considered unless the above conditions are fulfilled.
10. The school shall follow the traffic and safety guidelines indicated by the traffic police and fire service department

11. The parent teachers association meeting shall be conducted to sensitize the parents the safety of the children
12. The school shall have first aid Kit and the teachers shall be trained in first aid
13. The management is informed that no thatched roof accommodation is allowed to run the school
14. That the society shall provide fire safety measures in the school.

The Secretary /Correspondent, Sasi Educational Society, Velivenu is hereby informed that if the management failed to submit provisional recognition proposals as stipulated in condition above the temporary opening permission now accorded shall be deemed to have been cancelled and no further correspondence will be entertained. The management has to close the school if they failed to submit proposals for recognition on or before 30.04.2019 duly fulfilling all the conditions as stipulated in condition No 3 above. The management further informed that necessary action will be taken against the management as per the provisions of Section 20 (4) of Act 1 of 1982 (A.P. Education Act) if the management opens the school in the next academic year i.e. 2019-2020 without obtaining recognition from the competent authority.

The Inspecting Officer concerned has to maintain a Watch Register to watch whether the management submitted proposals for recognition and obtained recognition orders or not and see that the school is closed by 30-09-2019 if the management failed to obtain recognition orders from the competent authority and file necessary police complaint against the management of the school. If the school is functioning in the next academic year without recognition action will be initiated against the Inspecting officer.

Previously basing on the proposals submitted by the Correspondent, SASI EM Primary School, DNo.7-42-88, Sangivalasa, Bheemunipatnam Mandal, Visakhapatnam and recommendations of the inspecting officer concerned, Recognition has been accorded in the reference 6th & 7th cited for the years 2019-20 & 2020-21 to 2022-23 respectively for the classes I to V under English Medium.

Further the Government in the reference 4th cited, under Para No.1 (iii) has extend the recognition of the schools from 03 to 08 years those who have already taken recognition for a period of 03 years, to comply the orders dated 11.08.2023 of the Hon'ble High Court in W.P.No.18190 of 2023. - 14] The management informed that no thatched roof accommodation is allowed to run the school.

- 16] Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.

- 18] The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
- 19] The school shall have first aid kit and the teachers shall be trained in first aid.
- 20] The Correspondent of the concerned school is hereby informed to file and affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
- 21] That the management shall obtain and submit the structural soundness certificate every year before reopening of the School for the academic year.
- 22] That the management shall take every responsibility for the timely safely and comfortable mobility of the School Children from the residences to School and vice versa.
- 23] That the management shall ensure the Accounts of the School audited by an authorized Chartered Accountant every year and submit.
- 24] The management is hereby informed that the recognition is being given purely on temporary basis and is subject to the report of state level inspection and vigilance committee regarding fulfilment of all the pre-requisite conditions under A.P. Education Act 1982 and Right to Education Act'2009 and if later found that the school has not fulfilled any pre-requisites as stipulated, the recognition now being given is liable to be withdrawn at once.
- 25] The management should display fee structure and pay structure and qualified teachers list on the notice board
- 26] The school management shall obtain all latest NOC i.e., Fire NOC/Exemption of Fire NOC, Soundness Certificate & Sanitary Certificate time to time and submit the same to the Inspecting Officer. Any deviation in the NOC submitted by the management found later, the recognition now accorded will be deemed to be withdrawn.
- 27] The extension of recognition now accorded basing on the lease deed submitted by the management. If found any deviation, the recognition now accorded will be deemed to be withdrawn.
